- Providers of products or services with unfounded healing claims or miracle cures, offering medical advice not provided by a licensed healthcare provider, or promoting science denial.
- Readers and service providers using scamming or fearmongering tactics to pressure clients into purchasing remedies for curses.
- Vendors with AI images. Any booth displaying AI images will be kindly requested to exit the event without a refund.

DEADLINES

The vendor application will remain open through September 30th, 2024 or until all spaces are filled, whichever happens first.

Current rates shown will be honored through July 1st, 2024.

Rates are subject to change July 2nd.

NIGHT VENDORS & READERS

Vendors have the option to participate in both the daytime market and the Night Market, or choose one. The Night Market is scheduled for Saturday, October 12th, from 7pm to 10pm, running alongside the Witch's Ball.

PAYMENTS

Payment in full must be received with your registration. Payments are done online with a debit or credit card. We do not accept partial payments, checks or cash. Payments received on or before July 1, 2024 are eligible for the lowest registration price. Payments received between July 2nd and August 31st will increase to the middle registration fee, and payments received after August 31st must be in the amount of the last registration fee.

CANCELLATIONS & REFUNDS

There are no refunds for cancellations and no shows. Applications that are not approved will receive a full refund.

BOOTH RULES

- No more than two indoor vendors sharing a space
- All vendors must be listed on the registration form

SALES TAX COMPLIANCE

All participants are responsible for documenting their sales and paying Idaho State Sales Tax.

As required by the Idaho State Tax Commission, all participants who do not already have a Seller's permit or other temporary seller's permit must fill out an <u>ST124 form</u> online. All vendors are responsible for complying with local and state regulations for sales tax and other fees.

ADVERTISING

All Advertising materials for this event must include <u>Twin Falls Fairgrounds</u> as the venue location and <u>Twin Falls Witch's</u> <u>Market and Twin Falls Witch's Ball</u> as the organizers.

HOURS OF OPERATION – DAY VENDORS

- All vendors are required to be open for business from 10am to 6pm on Friday and from 10am to 4pm on Saturday.
- Vendors who are not participating as Night Vendors must tear down and exit the venue by 6pm on Saturday.
- All vendors will be required to set up on Thursday, October 10th, 2024 anytime 12pm-5pm.

HOURS OF OPERATION – NIGHT VENDORS

- All night vendors are required to be open for business from 7pm to 10pm on Saturday.
- All night vendors who are not participating as a day vendor (Fri-Sat) will be required to set up on Saturday, October 12th, 2024 between 4pm-6pm. Night vendor booths must be completely set-up by 6pm Saturday.
- Night vendors must tear down and exit the venue no later than 11:30pm Saturday

TABLES, TENTS and CHAIRS

Vendors must provide their own tent, tables, chairs, etc. as needed. 8-ft tables and chairs can be rented through the Twin Falls Witches Market and the payment for those items must be included in the registration fee at \$6 per table, \$2 per chair.

POWER / ELECTRICITY

Power is available at \$25 per plug (not per outlet). Plugging into power without pre-payment is not permitted. If plugs are available vendors can still rent them on set-up day, Thursday, October 10th. Vendors must provide their own extension cords and such.

WI-FI

High speed fiber optic wi-fi is available to all indoor vendors. Additional fees required by the Twin Falls County Fairgrounds for full coverage wi-fi has been paid by the Twin Falls Witch's Market and complementary to all indoor vendors.

RISK OF LOSS

Twin Falls Witch's Market, Twin Falls Witch's Ball, Sage & Crow, Root Witch Apothica`, Solaris Moon, Koffer & Koffer, LLC., Twin Falls County Fair & Rodeo, The County of Twin Falls, the City of Filer, their sponsors, officers, contractors, employees, volunteers and agents are not responsible for any loss, theft, damage or injury to any person or property.

PROHIBITED

- No firearms or drugs are allowed at this event.
- Service animals only -no other pets.
- Smoking or vaping indoors or outdoors within 25 feet of doors and entrances.
- Attaching anything to walls, floors or ceilings
- Open flames, fire (battery candles OK)

LOADING & PARKING

Vendors can unload their vehicle from designated loading zones but **must** park their vehicle before setting up.

LAWS & ORDINANCES

All vendors agree to be in compliance with all the rules and laws of Twin Falls County Fair & Rodeo, The County of Twin Falls, The City of Filer, The State of Idaho and all applicable Federal laws.

FOOD VENDORS ONLY:

- Food vendors are required to provide their menu along with a drawing of their trailer and any overhangs and service sides clearly marked along with their registration.
- All food and beverage vendors must sign an agreement with the Twin Falls County Fairgrounds, show proof of insurance and pay a \$25 fee to the Twin Falls County Fairgrounds prior to setting up for the event.
- Food Vendors may bring their own generator or connect to power on-site where available. You are responsible for bringing your own plug and extension cords
- Food vendors must provide their own ice.
- Set-up for Food trucks: Set-up times are 8am-9:30am Friday and Saturday. Must be ready to open no later than 10am.
